

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to Loriepointer.com, and Lorie Pointer Coaching and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Lorie Pointer Coaching include Loriepointer.com and LA Pointer LLC. ## Collection of your Personal Information

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Comply with an existing legal obligation; or
