CMO Report – by Rick Kirby

- 1) Insulation: Rick spoke with a man named Shaun and he said he would need to look into our application again since it has been quite some time since the original information was obtained. I told him about our BoD meeting today.
- 2) It seems we are sinking a lot of money into Lurch lately, however, it is most likely the one piece of equipment we cannot do without. We have ordered two caliper kits which has all the seals and pistons needed for repair. Apparently our Lurch book and the caliper parts person are not coinciding with one another. The book says use DOT 3 brake fluid and the parts supplier says to use mineral oil. However both types of seals are available so we have ordered EPDM which is compatible for DOT 3. The supplier is looking for the other two kits. The bogie cylinder, Rick has been told, is four or five weeks out.
- 3) The front two brake calipers for Lurch have been repaired. The parts are a bit pricey, but it is what it is. The repair shop said the pistons were frozen in their cylinders.
- 4) We also received a package with three hand held pre-programed railroad radios for crew operations. A big thank you goes out to RailCom who also provided the locomotive radios.
- 5) Rick wanted to discuss an idea that was brought up in our Board meeting. Due to this winter weather he wanted to see how everyone felt about rolling work days to avoid losing a work session. If the weather looks bad for say a Wednesday, maybe we could move it to Tuesday or Thursday. Everyone would need to pay close attention to their emails before they walk out the door. Usually Rick knows the day before, but this last week's worse weather moved to Thursday.

It appeared everyone was in agreement to do this, but after the holidays are over.

Dr. Mike added we would be having some "special projects" and that we might have some "surge weeks" to get that particular project done. There would be specific people assigned to each project.
