### MOBILE ADVOCACY TRAINING PROGRAM

The Mobile Advocacy Training
Program (MAP) is a training project
sponsored by the Arizona Coalition
for Victim Services (ACVS). The goal
of the program is to bring free
training to agencies who cannot
afford to attend traditional trainings.



#### WHAT WE DO

ACVS has been providing trainings for crime victim advocates and allied professionals since 2004. The AVAA Basic and Advanced Academies are the premier training events in the state for crime victim advocates.

The Mobile Advocacy Training Program will bring the same high quality, skill-based training to the requesting agency's location. ACVS's goal is to ensure advocates provide quality, consistent, trauma informed services to victims no matter where the victimization occurs.



#### **HOW DOES IT WORK?**

These trainings are typically two hours and cover 1 training topic however, other arrangements can be made with the approval of the AVAA Project Director. The Project Director will contact the requesting agency and work to provide the best trainer for the area and the agency needs.

It is preferable to have at least 10 attendees at each training. However, if an agency cannot meet that number, they are encouraged to open the training to other agencies in the area.

## HOW TO REQUEST A TRAINING:

To request a training, please review the requirements and fill out the Request for Training form (RFT) - the forms can be found on the ACVS website (AZCVS.net under the "Trainings" tab)


Once the request is received, the Project Director will contact you to schedule the training within 2 business days.

You must obtain an appropriate training site. ACVS will not be responsible for any cost associated with acquiring a training facility.

You agree to distribute, collect and return to the Project Director, evaluations of the training within a week

#### WHAT IS THE COST?

There is no cost to the agency for the training. AVCS will provide the trainer, copies of the training materials, and copies of the evaluations.
