

HOW TO ENDORSE FUTURE PLAN MANAGEMENT

The NDIS is undergoing some changes, including a new computer system called PACE.

If you're an existing participant, you'll switch to PACE at your next plan review, but if you are very new to the scheme, your first plan is likely created in the new PACE system. If this is the case, you will need to request that the NDIA endorse Future Plan Management as your authorised plan management provider using the following details:

We will arrange a three-way phone call between yourself, the NDIS Contact Centre and us. This is usually the fastest way to arrange endorsement after the plan has been finalised. [insert call us link]

NDIS My NDIS Participant Portal - if you have not yet set up access to the new portal via MyGov, follow this link to help you get started:

You can log in to MyGov (<https://my.gov.au/>) and access the My NDIS tile. Select the Relationship tab on the top right of screen and endorse us as your plan manager. We will then appear in the Active Relationships page.

You can also approve request from providers in this same area of the portal. If you would like us to send a request for you to approve, please let us know. This option is not done automatically as is it can confuse some participants.
