## RESERVATIONS + SCHEDULING

All photo sessions or shoots at the Woolery Mill must be scheduled and approved by the venue prior to the session. Unscheduled photo sessions will be asked to leave the property. Photo sessions cannot be scheduled on dates where an event is being hosted at Woolery Mill, as rental clients have exclusive access to the space during their rental. All photo sessions must be rescheduled if a paying client reserves Woolery Mill for an event that conflicts with the photo session.

## EXTERIOR SHOOTING

Photo shoots on the Woolery Mill grounds are free of charge and include no access to the interior of Woolery Mill. No climbing, standing, or sitting on exterior facades (limestone blocks, fountain, etc.) will be permitted at any time. Any guest breaking this rule will be asked to leave. Restrooms and/or spaces to change are not available.

## INTERIOR SHOOTING

Interior photo sessions are available at a rate of \$50/hr during business hours. (M-F 10am-5pm)  
Interior photo sessions are complimentary for couples who have booked Woolery Mill as their wedding venue. The interior space is available "as is" on the day of your session. You are not permitted to move furniture or equipment. A cleaning fee of \$100 will be charged if the space is not left in acceptable condition. All scheduled interior photo sessions must have a card on file for incidentals.

## MEDIA RELEASE

Photographers and clients must fill out and sign a media release form. All media shared must give credit to Woolery Mill as the site.
